## Purpose and lawful basis for processing

Our purpose for processing your personal data is to gather your opinion on what type of physical active that you and family would like to take part in.

We are processing the personal information you provide under the UK General Data Protection Regulation (UK GDPR). The lawful basis we are relying on to process your personal data is Article 6 (1) (a)of the UK GDPR, which allows us to process personal data when carrying our this consultation.

## Do we use any data processors?

Council have a contract with Delib Citizen Space to provide the Consultation Hub service as a method to gather the consultation responses. This service provides the online consultation platform for Council to design and publish online public engagement activities including consultations. This is also the service used by Council when it commissions third parties to carry out engagement activities, unless otherwise stated.
